INTERNATIONAL NICKEL STUDY GROUP



Veronique Steukers, Director H&E Public Policy, Head of Office, Nickel Institute spoke about "Nickel's Carbon Footprint Calculation: Relevance, Requirements, Methods, and Alignment.".

# RESPONSIBLE SOURCING OF BASE METALS – LATEST DEVELOPMENT

Paul White, the Common Secretary-General of ILZSG/ICSG/INSG, opened the seminar by mentioning that increasing amounts of critical or strategic materials would be required for the transition to green energy over the coming years.

Michael Lodge, Secretary-General, International Seabed Authority (ISA) discussed the exploration and potential resources of marine minerals in the ocean's seafloor and subsoil, particularly focusing on polymetallic nodules, cobalt-rich ferromanganese crusts, and polymetallic sulphides.

Louis Marechal, Conseiller Principal, Organisation for Economic Co-operation and Development (OECD) provided a focus on responsible business conduct (RBC) in critical and transition minerals supply chains.

Titas Anuskevicius, Policy Officer, European Commission reviewed the EU's Critical Raw Material act.

Michèle Brülhart, Executive Director, The Copper Mark discussed the evolution and vision of the Copper Mark concept.

Steve Binks, Senior Director, Regulatory Affairs, International Lead Association (ILA) outlined the requirements of a Responsible Sourcing Initiative for Secondary Lead Production.

Mingyou Yang, Responsible Business Manager, LME updated the audience on the LME's extensive responsible sourcing initiative.

#### CRITICAL MINERAL INITIATIVES AND STRATEGIES

Paul White, the Common Secretary-General of ILZSG/ICSG/INSG, opened the Joint Seminar by pointing out that governments and the general population have become increasingly aware of the importance of metals to the energy transition as well as the fact that the resources of many of those metals considered to be critical are limited.

Lauren Shelton, International Trade Specialist, Office of Critical Minerals and Metals, U.S. Department of Commerce, introduced the "United States Government's Critical Minerals Initiatives and Activities".
